Appendix 3B – Share Placement and Information Required under Listing Rule 7.1A

TZ Limited (ASX: TZL) (the **Company**) encloses an Appendix 3B in respect of the 57,886,493 ordinary shares issued pursuant to TZ Limited's recent share placement (further to the Company's announcement on 12 March 2015) (**Placement**). The shares were issued and allotted today, 18 March 2015. All shares issued under the Placement were issued at a price of 11 cents per share. Of the 57,886,493 shares issued, 5,929,233 shares were issued under Listing Rule 7.1A and the remaining shares were issued under the Company's 15% placement capacity under Listing Rule 7.1.

In accordance with the requirements of Listing Rule 3.10.5A, the following information is provided:

(a) The dilution to existing shareholders as a result of:

- the issue under Listing Rule 7.1 is 12.74%;
- the issue under Listing Rule 7.1A is 1.45%; and
- this total Placement is 14.20%.

These percentages represent the number of shares issued under the Placement as a proportion of the total number of ordinary shares on issue before the Placement.

(b) The Company issued shares under the Placement to sophisticated and institutional investors as it was considered to be a more efficient mechanism of raising money for the Company. The Placement did not expose the Company to market volatility that might have been experienced under a capital raising process over a longer time frame, such as a pro rata issue to existing security holders. In addition, under a recently completed share purchase plan, the Company issued shares on 5 March 2015 to eligible participating shareholders of the Company.

(c) There were no underwriting arrangements.
